C.S.ARCHITECTS (P) LTD., SALEM on behalf of PERARIGNAR ANNA HANDLOOM SILK PARK LTD., intends to invite Expression of Interest (EOI) for developing a 3750 Kld ZERO LIQUID DISCHARGE Common Effluent Treatment Plant (CETP) for the treatment of textile effluent at Kilkadhirpur village, Kanchipuram, Tamilnadu, India including the construction of the effluent collection system to convey the raw effluent from the member units to the CETP and to pump the treated water to the OHT on Build, Operate and Transfer (BOT) basis.

Preamble

Kanchipuram is a hub of silk textile industries wherein medium as well as small units are engaged in silk and cotton dyeing. The majority of small scale industries require a ZLTD - CETP in compliance with the Tamilnadu Pollution Control Board norms.

Components of the project

The project comprises the following components:

1. Designing CETP for a daily discharge of 3750Kl of Effluent.
2. Processing operation is mainly cotton yarn dyeing in cheese dyeing machine and silk dyeing by manual and semi automatic machine.
3. The class of dyestuffs used will be Reactives for cotton and Direct, Acid for silk in the approximate ratio of 80:20.
4. The treatment should comprise of equalisation, primary, secondary and tertiary treatments and conform to Zero Liquid Discharge norms of TNPCB.
5. All pipe lines designing both from the units to the CETP and IN the CETP is to be designed in proper manner.
6. CETP to treat 3750Kld of raw textile effluent complete with any of physico-chemical methods, Biological treatments, Membrane process followed by treatment of rejects and final sludge disposal.

Invitation for EOI

CSAPL on behalf of PAHSP now invites EOI from interested and experienced Engineering, Procurement and Construction (EPC) organizations specializing in implementation of treatment plant on physico chemical/ biological treatment methods, membrane process and evaporators and sludge disposal.

This EOI is to assess the experience and the capabilities of the applicant company. Therefore EPC organizations who have the experience and capability for the design, engineering, construction, supply of equipment, erection, testing & commissioning, O&M of any one or more of the above mentioned treatment methods and components are requested to furnish the details of their technical experience and financial standing in three sets of hard copies to CSAPL. The EOI submission in hard copies only will be accepted and not through e mail. The EOI submission inter alia should include the following.

1. Letter of interest
2. Company profile and catalogues
3. Reference list of similar projects executed and commissioned within the last 10 years in textile wet processing.
4. The reference list should indicate the name of the client, the location of the plant/s that have been designed, implemented and O&M for a minimum period of 5 year the capacity of the plant in terms of mld or cum/day, the month/year of award of the contract and the month/year of successful commissioning
5. Audited annual reports for the last three financial years.
